A letter No. OW no. 356 MSP/FRRO/2023 dated 20th April 2023 has been received from office of the Deputy Commissioner of Police & FRRO, SB-II, CID, Mumbai where he states that, "*the procedure delineated in the MHA circular and other guidelines, needs to be followed by all the agencies concerned so that the security concerns are duly addressed.*"

In view of above, all shipping agents are requested to obtain the NoC from immigration office. Copy of the NOC from immigration to be kept on board, same will be checked by Pilot prior sailing of the vessel. If copy of NOC from immigration not available, then the vessel will not be sailed from Mumbai Port.
