Sub: Unauthorized chipping / painting and repair works Carried out in Docks, Mumbai Port Authority (MbPA)

Mechanical & Electrical Engineering Department (MEED), Mumbai Port Authority issues/renews permits/Licenses to the applicants who wish to provide the repair services to agents/owners of vessels, berthed at MbPA's Indira Dock and Harbour Wall. (Berth nos. 1 to 4, 9 to 24 of Indira Docks, BPS, BPX, stream and anchorages).

- 2. There are 23 categories of specialized jobs (copy enclosed), for which registration of firms is done by MEED for respective category of job, based on their experience. The List of firms/agencies, registered for specialized jobs, including chipping/painting is available on the website of Mumbai Port Authority. (Link- Home/ Business / Permit / Ship Repairs Permit)
- 3. On the basis of license issued by MEED, Permit Section of Traffic Department grants registration to applicant agencies under the respective categories, including for carrying out repair works, chipping /painting work, etc. on-board the vessels in Docks and Stream.
- 4. Lately, a few instances have been reported, wherein chipping and painting works were carried out by the agencies/ workers on-board the vessels at Docks and Stream without the possession of the requisite license from MEED. It was observed that these unauthorised agencies/workers were provided the Dock Entry Permit (DEP) by the Vessel Agents, Ship chandlers etc., who should have refrained from facilitating such unauthorized activities by issuance of DEPs to such agencies/workers.

- It is pertinent to mention that the registered firms have dedicated infrastructure and set up to carry out the job, for which they are registered. Unregistered firms may not have the requisite expertise and specialized manpower, which may result in unsafe working conditions on / in Vessel and Port. Due to unauthorised work carried by the Unregistered firms, the registered firms are deprived of the legitimate business opportunities apart from the revenue loss to MbPA.
- In view of the above, it is hereby directed that Vessel Owners/Vessel 6. Agents shall appoint only registered firms/workers, having requisite valid license to carry out the specialized job on board the vessels at Docks and Stream. Docks Entry Permits shall be provided only to the firms/workers registered and authorized for carrying out the above mentioned specialized jobs including chipping and painting. It may be noted that any noncompliance of above will be viewed seriously and punitive action will be initiated against the defaulters.
- 7. It is requested to bring the above said instructions to the notice of your members for strict compliance.
