Madam,

On the above subject and reference, resurgence of Covid-19 cases in China, Singapore, Hongkong, South Korea, Thailand and Japan is a matter of concern with the circulation of SARS-COV-2 found in these countries.

2. Ministry of Health and Family Welfare has issued guidelines for International travels and the Secretary and Joint Secretary (Health) has issued letters on the same regarding pre-arrival Covid-19 testing of International Travellers to India which includes crews arriving for sign-off or passengers disembarking at Cochin Seaport.

3. Crews of foreign ships arriving at Cochin Seaport are regularly screened for Covid-19 disease on board and passengers arriving are thermally screened in Cruise Terminals.

4. Ships and crews arriving from the countries listed within 14 days will be mandatorily screened and crews planning for sign off will be tested for Covid-19 disease in ICMR approved laboratories.

5. Agents are requested to submit the required documents including crew list / passenger list, Port of call list, Maritime Declaration of Health (to be submitted daily for Cruise Vessels). 48 hours prior to the arrival of the ship in the port.

6. All crews / passengers, Port officials, Immigration and Customs Officials, Agents are requested to follow Covid-19 protocol for infection prevention and control measures in the Port at all times.


