### TRADE CIRCULAR

Sub: Suspension of operations at Berth 16(O) [erstwhile HOJ-I] of HDC, SMPA from 24.02.2025.

In terms of the directive of appropriate authority of HDC, SMPK, this is to inform all concerned that a shutdown for the removal of the damaged Marine Loading Arm and subsequent installation of new Marine Loading Arm work at Berth No. 16(O) [HOJ-I] will be taken w.e.f. 24.02.2025 to 28.02.2025 i.e., for a period of 5 days. The actual date of commencement of shutdown may vary slightly due to completion and sailing of the last working vessel at the jetty.

All users of HOJ-I are requested to be guided by the same and plan their vessels accordingly please. The duration of the above shutdown may increase in the event of exigency.
