Ltd.(JSW MCTPL) for handling Containers and other Clean Cargo on Design, Build, Finance Operate and Transfer (DBFOT) basis at NMPA, which may start its Commercial Operation tentatively from First week of March 2022.

The Concessionaire M/s.(JSW MCTPL) has been allowed to charge the Tariff as per the TAMP Order No. TAMP/69/2018-NMPT dtd.18.01.2019 notified in the Gazette of India Extraordinary (PART 3 Section 4) on 26th February 2019. The above tariff is subject to indexation as per tariff guidelines.
