Sub: Concessions for Export of Sugar.

Ref : This office Circulars

(1) No. TM/A/15-22/45 dated 23.12.2022

(2) No. TM/A/15-22/24 dated 28.12.2023

Mumbai Port is keen to attract export of agri products and has revamped its facilities attracting export of sugar in large quantities. With a view to encourage export of more agri products like sugar, rice, soyabean meals, maize, wheat etc. through Mumbai Port, an attractive scheme aiming at reduction of cost in Mumbai Port was conveyed to trade by referred circular dated 23.12.2022. The scheme was subsequently discontinued w.e.f. 01.01.2024 by Circular dated 28.12.2023, referred to above.

The abovesaid scheme for agri products is being reintroduced for export of sugar with terms and conditions as below:

(I) The slabwise rebate in stevedoring charges to the exporters for exporting sugar during the period 21.02.2025 to 20.02.2026 is as under :

01 to 24,999 tonnes -10% rebate
25,000 to 49,999 tonnes -15% rebate
50,000 tonnes and above – 20% rebate


(II) Free days/ Storage/ demurrage as below :

- (a) to allow first 30 days free i.e. from Day 1 to Day 30
- (b) to levy flat demurrage rate of Rs. 60/- per tonne per 15 days for the period 31st day to 45th day;
- (c) to levy flat demurrage rate of Rs. 90/- per tonne per 15 days for the period 46th day to 60th day; thereafter, to levy demurrage charges as per section 3.1 (B) of Scale of Rates (SOR) considering 61st day as Day 1.

(III) All sheds in Docks are nominated under abovesaid scheme.

- 2. The above rates/ scheme will be applicable for a period of one year from 21.02.2025 to 20.02.2026 and shall be reviewed thereafter.
- 3. All exporters of sugar are requested to avail the above facility and route their exports through Mumbai Port.
- 4. You are requested to give wide publicity amongst your members to avail the benefits of aforesaid concession.
