Sub: Registration of unorganised Dock Workers on
e- SHRAM portal.

Ref: Circular No. TM/S-1/76 dated 29.10.2021 and
TM/S-11/88 dated 14.12.2021

By Circular No. TM/S-1/76 dated 29.10.2021, it was requested for registration of all such workers who are coming under the category of unorganized workers through the facility available on e-SHRAM portal or with the help of Common Service Centres (CSCs) in Mumbai, details of which are available on e-SHRAM portal. It was also requested that details of such registration i.e. Name of the worker, their Universal Account No. (UAN) and date of registration may kindly be informed to Dock Entry Permit Section on daily basis on e-mail address:- *dep.mbpt@mumbaiport.gov.in*.

2. Further, by Circular No. TM/S-11/88 dated 14.12.2021, it was informed that it has been decided that all such workers shall be registered on e-SHRAM by 01.01.2022. Therefore, all the Port Users are requested to ensure that their workers are registered on e-SHRAM Portal by 01.01.2022. As requested by circular dated 29.10.2021, details of registration, if made on e-SHRAM portal or with the help of Common Service Centres (CSCs), may kindly be informed to Dock Entry Permit Section on daily basis on e-mail address:-*dep.mbpt@mumbaiport.gov.in*. If registration of such workers not done by due date, Dock Entry Permits (DEPs) will not be issued from 01.01.2022.


3. You are therefore requested to submit on full list of workers employed by you in following format **by 10.03.2022** on your letter head, with certification that this is full list of workers for which you are obtaining online / offline / manual DEPs.
