

TRADE NOTICE NO.07 /2022

Sub: - Concessional on handling Gypsum Cargo through non RR rakes - Reg.

The Board of Mormugao Port Authority (MPA), vide their Board Resolution No. 80 of 07.09.2022 have approved the following concession on handling of Gypsum cargo.

1. In order to attract any new cargoes, the period of non supply for only non-RR rakes (excluding the day of rake supply) against the particular indent shall be waived and considered as additional free period for the cargo loaded in that particular indent rake, till the day of rakes supplied instead of the waiver/concession on the delivery rate. This concession shall be valid for a period of 1 year or till the commissioning of the remaining portion of the new highway 17B connecting to Gate No. 9, whichever is earlier.

TRADE NOTICE NO. 06/2022

Sub: - Concessional Tariff, Common Circular - Reg.

The Board of Mormugao Port Authority (MPA), vide their Board Resolution No. 80 of 07.09.2022 have approved to issue a Common Circular in respect of various concession which are offered at West of Breakwater (WOB) by the port.

Accordingly the concessions shall be in supersession of all concessions offered at WOB vide (i.e. Board Resolution no 143 dated 16.07.2017, 2. Board Resolution no 129 dated 16.07.2021 and 3. Board Resolution no 7 dated 21.04.2020) are proposed as a common circular (except Iron ore concession offered vide Board resolution no. 156 dated 06.12.2021, valid till 30.06.2023).

1. If a vessel is lightered/fully unloaded/loaded/uptopped and the same cargo is then brought to the port's berth/taken away from port's berth by barges (including PPP operated terminals), then no wharfage and no charges for usage of floating crane/ transhipper shall be applicable for the cargo handled in stream. However, wharfage shall be charged at 100% of rates applicable at berth for cargo brought/ taken away by barge from/to Stream. For usage of any transhipper/floating crane licensed to operate in the Port which are deployed at berth/jetties for barge unloading when HMC is not available or already in use, the applicable SoR rate for usage of floating crane/transhipper shall be charged. No loading/unloading charges would be applicable for any private crane arranged by the user, except in cases where Transhipper loading charges have already been waived off at WOB.
2. Vessel operations at WOB shall be permitted/allowed only when Port's berths/MDs are occupied and having valid CTO or having valid restriction (to be recorded in writing) such as higher draft of the vessel, non-availability of HMC, etc., except for cape size vessels.
3. This concession shall be valid till June 2023 or till last arrival of vessel at WOB during June 2023, as weather/monsoon permits.
